Kids Club payments will begin on August 1<sup>st</sup> thru May 1<sup>st</sup>. **You must pay for the full amount even if your child does not stay for the number of days you sign this contract for. There is not a discount for the months with holidays and breaks.** SCCS reserves the right to charge additional fees if the child is not picked up during the designated time selected. If additional days are requested, the cost is \$10 per club (Kindercare/After-school) per day.
